# Boundary Line Adjustment - Railroad Market Description

That portion of Lots 8, 9 & 10 of Block 41 of the Amended Plat of Burlington recorded under AF16511 Skagit County Washington, described as follows:

Beginning at the northwest corner of Lot 8 thence S 1° 33' 16" W on the west line of Lot 8 a distance of 17.52 ft to the True Point of Beginning;

Thence S 01-33-16 W on the west line of Let 8 a distance of 87.98 ft. to the northerly railroad right of way;

Thence on the north railroad right of way N 64° 44' 26" E a distance of 73.63 ft. to the southerly extension of a common building line between the buildings on Lots 9 & Lot 10 as the buildings existed on November 2015;

Thence north on the said building line extension N 01° 37' 29" E a distance of 42.70 ft. to the north building line;

Thence west on the northerly building line N 88° 23' 15" W a distance of 43.54 ft. to the easterly edge of the concrete pad;

Thence north on the easterly edge of the concrete pad to its northerly edge N 01° 39' 35" E a distance of 12.09 ft.;

Thence west on the northerly edge of the concrete pad N 88° 37° 51" W a distance of 22.26 ft. to the true point of beginning;



Thence on the north line of Lots 8, 9 & 10 bearing S 88° 26' 49" E a distance of 90.00 ft.; Thence south on the easterly lot line of Lot 10 S 01° 33' 15" W a distance of 60.01 ft. to the northerly right of the railroad;

Thence southerly on the northerly railroad right of way S 64° 44′ 26″ W a distance of 27.21 ft. to the southerly extension of a common building line between the buildings on Lots 9 & Lot 10 as the buildings existed on November 2015:

Thence north on the said building line extension N 01° 37' 29" E a distance of 42.70 ft. to the north building line;


Thence west on the northerly building line N 88° 23' 15" W a distance of 43.54 ft. to the easterly edge of the a concrete pad;
