Boundary Line Adjustment - Railroad Market Description

That portion of Lots 8, 9 & 10 of Block 41 of the Amended Plat of Burlington recorded under AF16511 Skagit County Washington, described as follows:

Beginning at the northwest corner of Lot 8 thence S 1° 33' 16" W on the west line of Lot 8 a distance of 17.52 ft to the True Point of Beginning;

Thence S 01-33-16 W on the west line of Lot 8 a distance of 87.98 ft. to the northerly railroad right of way;

Thence on the north railroad right of way N 64° 44' 26" E a distance of 73.63 ft. to the southerly extension of a common building line between the buildings on Lots 9 & Lot 10 as the buildings existed on November 2015;

Thence north on the said building line extension N 01° 37' 29" E a distance of 42.70 ft. to the north building line;

Thence west on the northerly building line N 88° 23' 15" W a distance of 43.54 ft. to the easterly edge of the concrete pad;

Thence north on the easterly edge of the concrete pad to its northerly edge N 01° 39' 35" E. a distance of 12.09 ft.:

Thence west on the northerly edge of the concrete pad N 88° 37' 51" W a distance of 22.26 ft. to the true point of beginning;
