- ALL SURVEY CONTROL INDICATED AS "FOUND" WAS RECOVERED FOR THIS PROJECT IN JUNE & JULY, 2015.
- THIS IS A FIELD TRAVERSE SURVEY. A GEOMAX 3 SECOND COMBINED ELECTRONIC TOTAL STATION WAS USED TO MEASURE THE ANGULAR AND DISTANCE RELATIONSHIPS BETWEEN THE CONTROLLING MONUMENTATION AS SHOWN. CLOSURE RATIOS OF THE TRAVERSE MET OR EXCEEDED THOSE SPECIFIED IN WAC 332-130-090. ALL MEASURING INSTRUMENTS AND EQUIPMENT ARE MAINTAINED IN ADJUSTMENT ACCORDING TO MANUFACTURER'S SPECIFICATIONS.
- THE AREA OF THE PROPERTY IS CALCULATED TO BE: 30,600 SQ. FEET, OR 0.7025 ACRES, MORE OR LESS.
- THIS SURVEY SHOWS CALCULATED PLAT LINES, WHICH MAY BE DIFFERENT THAN OWNERSHIP LINES AS DETERMINED IN A COURT OF LAW.
- IT WAS DETERMINED AT FIRST THAT NO RECORD OF SURVEY WOULD BE NEEDED AS PLATTED DIMENSIONS FIT OVERALL FOUND EVIDENCE, BUT AFTER REVIEWING THAT THE MANHOLE LID MAY REVEAL POSSIBLE OTHER UNDERGROUND ENCROACHMENTS, IT WAS LATER DECIDED TO RECORD THE SURVEY. NO INSPECTION WAS DONE TO DETERMINE ANY UNDERGROUND UTILITIES, NOR WAS ANY EFFORT MADE TO RESEARCH POSSIBLE EASEMENTS THAT MAY COVER THIS MANHOLE BUT THAT ARE NOT SHOWN ON THE RECORDED PLAT.
