DESCRIPTION:

PARCEL "A":

All that portion of Government Lot 1, Section 30, Township 35 North, Range 2, W.M., described as follows:

Beginning at the intersection of the South line of said Government Lot 1 with the West line of Commercial Avenue in the City of Anacones, Skagit County, Washington;

thence North along the West line of said Commercial Avenue 150.0 feet to the true point of beginning; thence South 89°52' West parallel with the South line of said Government Lot 1 for a distance of 129.78 feet; thence North 0°30'15" West, 142.53 feet to the centerline of the alley produced West from Block 2 of Whitney's First Addition to the City of Anaportes;

thence East along the centerline of said alley produced to the West line of Commercial Avenue; thence South along the West line of Commercial Avenue 142.22 feet to the true point of beginning;

Situate in the County of Skagit, State of Washington.
