DESCRIPTION:

PARCEL "A":

That portion of Lot 56, "FOREST ESTATES, PLAT NO. 2", as per plat recorded in Volume 8 of Plats, pages 101 and 102 records of Skagit County, Washington, lying Southerly of the following described line:

Beginning at the Southwest corner of said Lot 56;

thence North 1°06'30" West, along the West line thereof, a distance of 328.55 feet;

thence Easterly along a non-tangent curve concave to the South whose radius point bears South 3°18'10" East, a distance of 738.39 feet, having a delta of 11°39'16", an arc distance of 150.19 feet;

thence South 81°38'54" East a distance of 74.38 feet to the East line of Lot 56:

thence South 1°06'30" East, along said line, a distance of 60.83 feet to the true point of beginning of said line; thence North 81°38'54" West, a distance of 84.37 feet;

thence on a curve to the left having a radius of 678.39 feet, through a delta of 11°50'55", an arc distance of 140.29 feet to the West line of said Lot 56 and the end of said line.

thence North 89°04'37" East, along the South line thereof, a distance of 173.00 feet to the true point of beginning;

thence North 1°06'30" West, a distance of 264.40 feet;

thence Easterly on a non-tangent curve concave to the South whose radius point bears South 7°44'02" East, a distance of 678.39 feet, having a delta of 4°14'13", an arc distance of 50.17 feet to the East line of said Lot 57:

thence South 1°06'30" East along said line, a distance of 268.50 feet to the Southeast corner of said Lot 57; thence South 89°04'37" West, a distance of 50.00 feet, more or less, to the true point of beginning.
