MEMORANDUM OF ASSIGNMENT OF GROUND LICENSE AGREEMENT

THIS MEMORANDUM OF ASSIGNMENT OF GROUND LICENSE AGREEMENT (the "MEMORANDUM") is made as of the 27th day of January, 2016, by and between PI Telecom Infrastructure LLC, a Delaware limited liability company (the "Assignor"), and PI Tower LLC, a Delaware limited liability company (the "Assignee").

1. Assignor, as licensee, and Sierra Pacific Industries, a California corporation, as licensor, entered into that certain Communications Site License Agreement (as same may be amended from time to time, the "Agreement"), dated October 1, 2014, as evidenced by that certain instrument recorded under Auditor's No. 201508270087 of the Auditor's Office of Skagit County, Washington.

3. This Memorandum does not set forth the entire Assignment, and is solely intended to give notice thereof. If any conflict exists between the provisions of this Memorandum and the provisions of the Assignment, the provisions of the Assignment shall control.

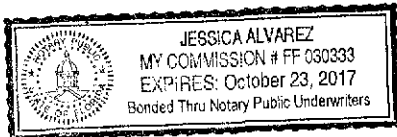
