**LEGAL DESCRIPTION.** The real property that is the subject of this revocable Transfer on Death Deed is situated in the County of Skagit, State of Washington, and it is legally described as follows:

The Easterly 80 feet of the Northerly 180 feet of the Southerly 444 feet of the following described tract:

That portion of the Northeast Quarter of the Northeast Quarter of Section 19, Township 35 North, Range 4 East of the W.M., described as follows: 50 feet distant Easterly (measured at right angles) from the center line of the railway of the Great Northern Railway Company as formerly located and constructed, but now abandoned; thence Southeasterly parallel with said center line and 50 feet distant therefrom 975 feet; thence Southwesterly at right angles to the last described course 110 feet, more or less, to the Easterly boundary of State Highway No. 1, as now laid out and established; thence Northwesterly along said Easterly boundary to the North line of said Section 19; thence East along said North line 95 feet, more or less, to the point of beginning.



The transfer that will occur pursuant to this revocable Transfer on Death Deed at the time of the Grantor's death is exempt from the Washington Real Estate Excise Tax by reason of RCW 82.45.010 (3)(b) and WAC 458-61A-202(7).
