1. **Grantors.** I, **JOHN W. FORSYTH**, am the duly appointed, qualified, and acting Personal Representative of the estate of **ARLENE R. FORSYTH**, deceased, Skagit County, Washington, Superior Court Case No. 15-4-00006-3.

2. **Grantee(s).** The Grantee is **JOHN W. FORSYTH**, the beneficiary(s) of **ARLENE R. FORSYTH's** Will.

3. **Decedent's Estate.** Decedent, **ARLENE R. FORSYTH**, died on November 16, 2014, with a validly executed Will dated August 11, 1998. On January 8, 2015, Grantor was appointed Personal Representative of Decedent **ARLENE R. FORSYTH'S** Will and granted Nonintervention Powers for the administration of Decedent's estate.

4. **Beneficiaries.** **JOHN W. FORSYTH** is the beneficiary of Decedent's estate.


