This Memorandum of Lease dated the Hth day of March, 2016, is by and between PORT OF SKAGIT COUNTY, a Washington municipal corporation ("Lessor"), 15400 Airport Drive, Burlington, WA 98233 and MW KEMPER, LLC, a Washington limited liability company ("Assignee/Lessee"), 182 Hiline Road, Bellingham, WA 98229.

1. Property Leased. The Lessor leased to CHUCKANUT BREWERY, LLC, a Washington limited liability company ("Assignor/Lessee"), 182 Hiline Road, Bellingham, WA 98229, and Assignor/Lessee leased from Lessor, that real Property (the "Premises") described as follows:

pursuant to a Land Lease Agreement by and between Port of Skagit County, as Lessor, and Chuckanut Brewery, LLC, as Lessee, dated June 18, 2015 which Lease Agreement was then subject to the First Amendment to Lease Agreement by and between Port of Skagit County, as Lessor, and Chuckanut Brewery, LLC, as Lessee dated November 10, 2015 (collectively, the "First Amended Lease").
