MEMORANDUM OF LEASE

This Memorandum of Lease dated as of the day of March, 2016 is made and entered into by and between HINTON FAMILY, LLC, a Washington limited liability company and GREGORY T. HINTON as his separate property with an address at 18105 NE 23rd St., Redmond, WA 98052 (jointly and severally "Landlord"), and HARBOR FREIGHT TOOLS USA, INC., a Delaware corporation, with an address at 26541 Agoura Road, Calabasas, California 91302 ("Tenant") respecting that certain unrecorded lease of even date herewith (the "Lease").

Pursuant to the Lease, Landlord and Tenant hereby acknowledge and affirm that:

- 1. Landlord has leased to Tenant and Tenant has leased from Landlord that certain real property (the "Real Property") in the City of Mt. Vernon, County of Skagit, State of Washington. The Real Property is legally described on <u>Exhibit "A"</u> attached hereto and incorporated herein by reference, and the Real Property is shown on <u>Exhibit "B"</u> attached to the Lease
- 2. The term of the Lease is for a period of ten (10) Lease Years (as defined in Paragraph 2 of the Lease), commencing on the Lease Commencement Date as described in the Lease and terminating on the last day of the tenth (10th) full Lease Year, unless sooner terminated or extended pursuant to the terms of the Lease.
- 3. Tenant has five (5) successive options, each of which entitles Tenant at its election to extend the then current Term for an additional period of five (5) years per Option Term, subject to all of the provisions of the Lease.
- 4. The Premises may be used as a retail store selling tools, hardware, electronic goods, and related items and accessories (including, without limitation, automotive and motorcycle accessories and supplies, engines and generators, garage and machinery equipment and

material handling equipment, parts and supplies), seasonal merchandise, and/or for the sale of any other lawful products and/or services.

5 Landlord and Tenant further acknowledge and affirm that this Memorandum of Lease is not a complete summary of the Lease. Accordingly, Landlord and Tenant hereby agree that this Memorandum of Lease shall not be used in interpreting the Lease provisions and that, in the event of conflict between this Memorandum of Lease and the Lease, the Lease shall control.
