THE LAND REFERRED TO HEREIN BELOW IS SITUATED IN THE COUNTY OF SKAGIT, STATE OF Washington, AND IS DESCRIBED AS FOLLOWS:

LOT 30, BLOCK 42, PLAT OF THE TOWN OF MONTBORNE, SKAGIT COUNTY, WASHINGTON, AS PER PLAT RECORDED IN VOLUME 2 OF PLATS, PAGE 80, RECORDS OF SKAGIT COUNTY, WASHINGTON.

EXCEPT THE NORTHEASTERLY 40 FEET FOR COUNTY ROAD AS CONVEYED TO SKAGIT COUNTY BY DEED RECORDED JULY 14, 1941, IN VOLUME 184, PAGE 341, RECORDS OF SAID COUNTY AND STATE.

TOGETHER WITH THAT PORTION OF VACATED LAKESIDE BOULEVARD ADJOINING SAID PREMISES.

TOGETHER WITH THE SOUTHEASTERLY HALF OF VACATED LAFAYETTE STREET ADJOINING SAID PREMISES PURSUANT TO JUDGMENT ENTERED IN SKAGIT COUNTY SUPERIOR COURT CAUSE NO. 98-2-01307-1, EXCEPT SAID NORTHEASTERLY 40 FEET FOR ROAD REFERRED TO ABOVE.

ALSO TOGETHER WITH THAT PORTION OF THE 100 FOOT WIDE RAILROAD RIGHT-OF-WAY COMMONLY KNOWN AS THE NORTHERN PACIFIC RAILWAY (AND ORIGINALLY CONVEYED TO THE SEATTLE LAKE SHORE AND EASTERN RAILWAY), LYING WESTERLY OF THE CENTERLINE OF SAID RIGHT-OF-WAY AND BETWEEN THE NORTHEASTERLY EXTENSIONS OF THE NORTHWESTERLY AND SOUTHEASTERLY LINES OF THE ABOVE DESCRIBED PROPERTY.

SITUATE IN SKAGIT COUNTY, WASHINGTON.
