I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that a WRIT FOR ORDER OF SALE did issue out of the Superior Court of SKAGIT County, Washington, on February 9, 2015, upon a judgment rendered in Superior Court of SKAGIT County, Washington on November 14, 2014, in favor of ONEWEST BANK, FSB, ITS SUCCESSORS IN INTEREST AND/OR ASSIGNS, for the sum of two hundred twelve thousand eight hundred fifty-eight dollars and fifty-six cents (\$212,858.56).

The WRIT FOR ORDER OF SALE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on February 10, 2015, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the WRIT FOR ORDER OF SALE.
