

3	III. DECREE OF FORECLOSURE
4 5	3.1 Plaintiff's lien shall be a first and prior lien upon the following-described real property, superior to any right, title, claim, lien or interest on the part of the Defendant or persons claiming by, through or under the Defendant:
6 7	Dot 45, Block D, "CAPE HORN ON THE SKAGIT", as per the plat recorded in Volume 8 of Plats, pages 92-97 inclusive, records of Skagit County, Washington.

9	3.2 The lien described herein shall be foreclosed and the said real property shall be sold in one or more parcels in accordance with and in the manner provided by law.
10	3.3 Plaintiff shall be permitted to be a purchaser at the sale; that the net proceeds of said sale
11	be applied first toward the payment of the costs of said sale and then towards the payment of Plaintiff's judgment.
12	3.4 Plaintiff shall have and retain a deficiency judgment against Defendant Rickman, in the
13	event that the bid(s) at the sale(s) are less than the sum of Plaintiff's entire judgment, plus the costs of sale.
14	3.5 After the sale of said property, all right, title, claim, lien or interest of the Defendant, and
15	of every person claiming by, through or under the Defendants, in or to said property, including the right of possession thereof from and after said sale, be forever barred and
