EXHIBIT A DESCRIPTION ROAD RIGHT OF WAY SOUTHWEST CORNER ANACORTES STREET AND EAST GILKEY ROAD

That portion of Tract 79, "PLAT OF THE BURLINGTON ACREAGE PROPERTY", as per plat recorded in Volume 1 of Plats, page 49, records of Skagit County, Washington, described as follows:

Commencing at the Northeast corner of the Southwest ¼ of Section 5, Township 34 North, Range 4 East, W.M.;

thence North 89°35'13" West on the North line of the Northwest ¼ of said Section 5 a distance of 30.00 feet to the West margin of Anacortes Street and the Point of Beginning; thence continuing North 89°35'13" West on said North line a distance of 18.43 feet; thence Southeasterly along a non-tangent curve to the left, having a central angle of 45°08'12", a radius of 48.53 feet, an arc length of 38.23 feet and a chord bearing South 19°22'44" East a distance of 37.25 feet;

thence continuing Southeasterly along a reverse curve to the right, having a central angle of 41°32'06", a radius of 24.98 feet, an arc length of 18.11 feet and a chord bearing South 21°10'45" East a distance of 17.71 feet to said West margin;

thence North 0°21'39" East on said West margin a distance of 51.52 feet to the point of beginning.
