Parcel "A" (Skagit County Assessor's Parcel No. P-22005)

The West 1/2 of the Northwest 1/4 of the Northeast 1/4 of Section 15, Township 34 North, Range 3 East of the W.M.:

EXCEPT ditch rights of way;
