That portion of Tract 13, "L.W.L. CO'S SAMISH RIVER ACREAGE, PLAT NO. 1, SKAGIT CO.,

WASHINGTON," as per plat recorded in Volume 3 of Plats, page 69, records of Skagit County, Washington, described as follows:

Beginning at the most Southerly corner of that certain tract of land conveyed to Harold S. Pierson and C. D. Pierson, by deed dated April 6, 1944, and recorded June 30, 1947, in Volume 219 of Deeds, page 143, under Auditor's File No. 406148, records of Skagit County, Washington, on the Northeasterly line of the State
