This boundary line adjustment is not for the purpose of creating an additional building lot. The property

described above composes one undivided parcel. The division of the parcel into sections A, B, C, D, E

within this deed is for clarity alone and does not imply that this property is actually five separate parcels.

The above lot line adjustment will create a parcel containing structures which do not comply with

minimum setback requirements. The Grantee hereby agrees that any future construction requiring a

building permit from the City of Mount Vernon, which is performed on structures deemed nonconforming with respect to minimum setback requirements as a result of this boundary line adjustment, shall require compliance with applicable prinimum setback requirements or shall require a variance from the City of Mount Vernon gripr to construction. For a structure that is subject to this paragraph, "compliance with minimum setback requirements" shall be defined as and require that new construction be restricted to thet area which is a distance from the lot line equal to the sum of the following:

- 1.) The minimum setback requirements for the lot on which new coastruction is occurring; and
- 2.) The number of feet that a permanent, pre-existing structure on an adjaining lot encroaches upon the

minimum setback requirement as required at the date of this document. This paragraph shall apply only

to those structures that are in non-compliance with setback requirements in effect at the date

document, as a result of this boundary line adjustment."
