Amendment to Protective Covenants, Conditions and Restrictions of Channel View LLC Skagit County (Auditors File Number 200312170067,) dated 12/17/2003.

The amendment references section 5a, 5b, 5c, 5d and 5f (pages 4 and 5 of above named document.) This amendment was approved and adopted by a vote of 9 of 12 of the eligible owners of the Channel View Water Association.

6 a. Power of the Board to Grant a Variance: The Board of Directors of the Channel View Water Association (CVWA), also acting as the Architectural Review Committee (ARC) for the Channel View Home Owners Association, shall have the power to grant a variance to an owner, who, at the time the owner submits the proposed plans to the ARC for approval, also submits a request for a variance. The variances which may be allowed by the Board shall be limited to those matters herein covered in section 5a (Residential Purpose), 5c (Roofs), 5d (Siding), 5f (Required Landscaping). The granting of the request for a variance shall be in writing and shall also be entered in the minutes of the Board.

Any variances approved by the Board, must also be approved by the majority of eligible owners as described in the recorded CC & R's of Channel View LLC, by not less than 75% of the total eligible number.
