submitted by defendants pursuant to CR 56. After hearing the argument of counsel, the court granted plaintiff's motion. The court's order awarded plaintiff the sum of \$28,912.86 as damages, interest on this sum since March 20, 2015, and reasonable attorney fees.

Based upon the argument of counsel, pleadings, order and evidence presented, the Court enters final judgment as follows:

- 1. Plaintiff is awarded the sum of \$28,912.86 as damages against defendants for breach of fiduciary duty.
- 2. Interest on the dates so awarded since March, 2015 at the rate of 12% per amum. \$5,205.45
- 3. The sum of \$6,813.75 as reasonable attorney fees for bringing this action.
- 4. Costs in the amount of \$130.69.




