I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that a ORDER OF SALE did issue out of the Superior Court of SKAGIT County, Washington, on October 26, 2015, upon a judgment rendered in Superior Court of SKAGIT County, Washington on March 24, 2015, in favor of FEDERAL HOME LOAN MORTGAGE CORPORATION, for the sum of two hundred forty-eight thousand, five hundred seventy dollars and eighty-nine cents (\$248,570.89).

The ORDER OF SALE, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on November 12, 2015, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the ORDER OF SALE.
