- 1. All equipment, inventory and Trade Fixtures. "Trade Fixtures" shall be defined as any furniture or furnishings as well as any piece of equipment or improvement on or attached to the real estate which are not normally required for the occupancy of the building. Trade Fixtures shall include all improvements made by the Debtor, whether or not financed by the Secured Party. Trade Fixtures shall include, but are not limited to, tanks, hoppers, scaffolding, shelving, catwalks, spouting and transition equipment, storage bins, tanks, bucket elevators, conveyors, automation systems, and all attachments additions and accessions, including electrical systems associated with the functioning of these equipment, but shall not include gas and electric fixtures, lights, ceiling and wall exhaust fans, HVAC systems, fire extinguishing apparatus, carpeting, etc., normally required for the occupancy of the building.
- 2. All Debtor's compensation, awards, damages, rights of action and proceeds, including interest thereon and/or the proceeds of any policies of insurance therefore, arising out of or relating to a taking or damaging of the equipment, inventory or Trade Fixtures thereon by reason of any public or private improvement, condemnation proceeding (including change of grade), or fire, earthquake or other casualty.
- 3. Return premiums or other payments upon any insurance at any time provided for the benefit of the secured party.
- 4. All Debtor's plans, specifications, contracts and agreements for construction of any improvements on the premises; debtor's rights under any payment, performance, or other bond in connection with construction of improvements on the premises; all Debtor's landscaping and construction materials, supplies, and equipment used or to be used or consumed in connection with construction of improvements on the premises whether stored on the premises or at some other location; and contracts, agreements, and purchase orders with contractors, subcontractors, suppliers, and materialmen incidental to construction of improvements on the premises; and
