## **EXCEPTIONS:**

A. RESTRICTIVE COVENANTS AS CONTAINED IN THE DEDICATION OF THE PLAT, A COPY OF WHICH IS HERETO ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF.

Said Covenants were extended and renewed until January 1, 2019 according to instrument recorded December 31, 1998, under Auditor's File No. 9812310011.

NOTE: The face of the plat of Samish Shores Plat contains the following recitation:

"The platter are also owners of record of tidelands fronting on said plat lying between the Easterly and Westerly lines of said plat produced North and extending to the line of extreme low tide. Hereafter, an undivided one-fortieth interest in said tidelands and an undivided one-fortieth interest in any portion of said plat designated as Reserved Tract "A" shall be deemed a part of each lot and shall pass with the conveyance thereof. Such undivided interests shall not be dealt with separately in any manner."
