## Legal Description

The land referred to in this report/policy is situated in the State of Washington, County of Skagit, and is described as follows:

That portion of Lot 1 of Skagit County Short Plat No. 94-014, approved August 2, 1994 and recorded August 5, 1994, in Volume 11 of Short Plats, page 95, under Auditor's File No. 9408050002, records of Skagit County, Washington; being a portion of the Southwest 1/4 of Section 17, Township 35 North, Range 5 East, W.M., lying East of the following described line:

Commencing at the Southwest corner of said Section 17;

Thence 86°16"36" East along the South line of the Southwest quarter of said Section 17, for a distance of 788.93 feet to the Southeast corner of Lot 2 of said Short Plat 94-014;

Thence North 0°12'29" West along the East line of said Lot 2, for a distance of 767.69 feet to a point on the Southerly boundary of Lot 1 of said Short Plat 94-014 and the point of beginning of said line; Thence North 0°12'29" West 1181,02 feet to the South line of the Great Northern Railway right of way and the terminus of said line.
