## GRANT OF EASEMENT FOR DEDICATION OF PUBLIC RIGHT-OF-WAY

THE GRANTOR, SIMILK, INC., a Washington corporation, for no consideration, grants, conveys and dedicates to the CITY OF ANACORTES, a municipal corporation of the State of Washington, an easement over, under and across that real property legally described below for use as a public rightof-way, situated in the City of Anacortes, County of Skagit, State of Washington including any interest therein, which Grantor may hereafter acquire:

THAT PORTION OF GOVERNMENT LOT 1, SECTION 5, TOWNSHIP 34 NORTH, RANGE 2 EAST OF THE W.M., A RIGHT OF WAY DEDICATION MORE PARTICULARLY DESCRIBED AS **FOLLOWS:** 

BEGINNING AT THE EAST QUARTER CORNER OF SAID SECTION 5, BEING NO2°25'44"W 2,631.94 FEET FROM THE SOUTHEAST CORNER OF SAID SECTION, THENCE ALONG THE SECTION LINE NO1°56'13"E 135.95 FEET TO THE SOUTH RIGHT OF WAY MARGIN OF STATE ROUTE 20 BEING A CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 1/800 FEET WITH A BEARING OF S13º18'00'W; THENCE NORTHWESTERLY ALONG SAID MARGIN 12.40 FEET ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 00°23'41"; THENCE S00°56'23"W 138.44 FEET; THENCE S01°49'14"W 273.81 FEET; THENCE S01°37'25"W 210.28 FEET; THENCE \$06°05'52"W 51.01 FEET, TO A CURVE CONVEX TO THE SOUTHWEST HAVING A RADIUS OF 118 FEET; THENCE SOUTHWESTERLY ALONG SAID MARGIN 118.45 FEET ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 57°30'54"; THENCE S87°34'16"E 68.04 FEET TO THE INTERSECTION OF THE SOUTHERLY RIGHT OF WAY MARGIN OF CHRISTIANSEN ROAD AND SAID SECTION LINE; THENCE NORTHERLY ALONG SAID SECTION LINE NO2°25'44"E 630.95 FEET TO THE POINT OF BEGINNING.

CONTAINING 7,673 SQUARE FEET MORE OR LESS.

SUBJECT TO AND TOGETHER WITH ALL RIGHTS, EASEMENTS, CONDITIONS RESTRICTIONS OF RECORD.

Together with a utility, ditch and storm drainage maintenance easement over, under and across a corridor adjoining the Westerly margin of the above described roadway dedication area

BEGINNING AT THE NORTHWEST CORNER OF SAID DEDICATION AREA AND ALONG THE SOUTH RIGHT OF WAY MARGIN OF STATE ROUTE 20 ON A CURVE CONCAVE TO THE NORTHWEST HAVING A RADIUS OF 1,800 FEET; THENCE NORTHWESTERLY ALONG SAID MARGIN 15.35 FEET ALONG SAID CURVE THROUGH A CENTRAL ANGLE OF 00°29'19"; THENCE S01°44'14"W 476.00 FEET; THENCE S03°30'29"W 186.30 FEET; THENCE S23°47'55"W 63.75 FEET; THENCE DUE SOUTH 12.75 FEET;

THENCE DUE EAST 22.60 FEET TO THE WESTERLY MARGIN OF SAID DEDICATION AREA; THENCE NORTHERLY ALONG SAID MARGIN TO THE POINT OF BEGINNING.

CONTAINING 13,432 SQUARE FEET MORE OR LESS

SITUATE IN SKAGIT COUNTY, WASHINGTON.

Said easement is reserved for and conveyed to the City of Anacortes and their respective successors and assigns for the purposes of utilities and storm drainage to construct, operate, maintain, repair, replace and enlarge the storm drainage conveyance system, underground pipes, conduits, caples, wires, ground mounted appurtenances and all necessary appurtenances thereto.
