## RECITALS:

- This Conveyance is made pursuant to the powers, including the power of sale, 1. conferred upon said Trustee by that certain Deed of Trust between Jessica L. Veilleux, An Unmarried Woman, as Grantor, to First American Title as Trustee, and Mortgage Electronic Registration Systems, Inc. ("MERS") as nominee for Lehman Brothers Bank, FSB, A Federal Savings Bank its successors and assigns, as Beneficiary, dated July 26, 2005, recorded July 29, 2005, as No. 200507290069, records of Skagit County, Washington.
- Said Deed of Trust was executed to secure, together with other undertakings, the 2. payment of a promissory note(s) in the sum of \$124,800.00 with interest thereon, according to the terms thereof, in favor of Mortgage Electronic Registration

Systems, Inc. ("MERS") as nominee for Lehman Brothers Bank, FSB, A Federal Savings Bank its successors and assigns, and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.

- 3. The described Deed of Trust provides that the real property conveyed therein is not used principally for agricultural or farming purposes.

Default having occurred in the obligations secured and/or covenants of the Grantor as set forth in "Notice of Trustee's Sale" described below, which by the terms of the Deed of Trust made operative the power to sell, the thirty day advance "Notice of Default" was transmitted to the Grantor, or his successor in interest, and a copy of said Notice was posted or served in accordance with law.

- 7. The Trustee, in its aforesaid "Notice of Trustee's Sale," fixed the place of sale as At the Main Entrance to the Skagit County Courthouse 3rd & Kincaid St. located at 205 W. Kincaid St., Mount Vernon, WA a public place at 10:00 am, and in accordance with law, caused copies of the statutory "Notice of Trustee's Sale" to be transmitted by mail to all persons entitled thereto and either posted or served in compliance with the requirements of RCW 61.24.031 and RCW 61.24.040; further, the Trustee caused a copy of said "Notice of Trustee's Sale" to be published once between the thirty-fifth and twenty-eighth day before the date of the sale and once between the fourteenth and seventh day before the date of the sale in a legal newspaper in each county in which the property or any part thereof is situated; and further, included with this Notice, which was transmitted or served to or upon the Grantor or his successor in interest, a "Notice of Foreclosure" in substantially the statutory form, to which copies of the Grantor's Note and Deed of Trust were attached.
