- 2. The real property being transferred is located within the Cascade Ridge P.U.D; and
- 3. Many years ago, all the roads within Cascade Ridge P.U.D. were taken over by Skagit County except Osprey Court; and
- 4. Osprey Court is a short road that is used by the owners of only 3 lots (the Grantees) in the approximately 40 lot Cascade Ridge P.V.D development; and
- 5. CASCADE RIDGE P.U.D. HOMEOWNERS' ASSOCIATION would like to quitclaim Osprey Court, as described above, to the three (3) Grantees named in this deed in order to relieve itself of any responsibility and liability for Osprey Court and Grantees want to accept ownership of Osprey Court.
- 6. No consideration is being given for the granting of the above described real property to Grantees.


