DESCRIPTION:

That portion of Government Lot 3, Government Lot 4, Government Lot 9 and Government Lot 10 of Section 19, Township 33 North, Range 4 East, W.M. described as follows:

RESOLUTION NO. 2240-16

A RESOLUTION OF THE COMMISSION OF PUBLIC UTILITY DISTRICT NO. 1 OF SKAGIT COUNTY, WASHINGTON, APPROVING AND CONFIRMING THE ASSESSMENTS AND ASSESSMENT ROLL OF MANN ROAD LOCAL UTILITY DISTRICT NO. 31, WHICH HAS BEEN CREATED AND ESTABLISHED FOR THE PURPOSE OF ACQUIRING, CONSTRUCTING AND INSTALLING A WATER MAIN AND APPURTENANCES WITHIN THE DISTRICT, AS PROVIDED BY RESOLUTION NO. 2226-15, AND LEVYING AND ASSESSING THE COST AND EXPENSE THEREOF AGAINST THE SEVERAL LOTS, TRACTS, PARCELS OF LAND AND OTHER PROPERTY SHOWN ON THE ROLL, AND PROVIDING FOR THE COLLECTION THEREOF

WHEREAS, the assessment roll levying the special assessments against properties located in Local Utility District ("LUD") No. 31 in Public Utility District No. 1 of Skagit County, Washington (the "District"), has been filed with the Secretary of the Commission of the District as provided by law; and

WHEREAS, notice of the time and place of hearing thereon and making objections and protests to the roll was duly published at and for the time and in the manner provided by law, fixing the time and place of hearing thereon for October 25, 2016, at 5:00 PM, local time, in the Aqua Room of the District located at 1415 Freeway Drive, Mount Vernon, Washington, and further notice thereof was duly mailed by the Secretary of the Commission to each property owner shown on the roll; and

WHEREAS, at the time and place fixed and designated in the notice, the hearing was held for the purpose of hearing all persons who had filed a written protest received prior to 12:00 noon on October 25, 2016, by mail or by personal delivery at the office of the District, and who wished to be heard; and the Commission of the District, sitting and acting as a Board of Equalization for the purpose of considering the roll and the special benefits to be received by each lot, parcel and tract of land shown upon such roll, including the increase and enhancement of the fair market value of each such parcel of land by reason of the improvement, received no such protests to consider;

NOW, THEREFORE, AFTER DUE CONSIDERATION AND BEING FULLY INFORMED, BE IT RESOLVED as follows:

Section 1. The assessments and assessment roll of LUD No. 31, which has been created and established for the purpose of acquiring, constructing and installing a water main and appurtenances within the District, as provided by Resolution No. 2226-15, as the same now stand, shall be and the same are approved and confirmed in all things and respects in the total amount of \$269,795.99.

Section 2. Each of the lots, tracts, parcels of land and other property shown upon the assessment roll is determined and declared to be specially benefited by this improvement in at least the amount charged against the same, and the assessment appearing against the same is in proportion to the several assessments appearing upon the roll. There is levied and assessed against each lot, tract, parcel of land and other property appearing upon the roll the amount finally charged against the same thereon.

Section 3. The assessment roll as approved and confirmed shall be filed with the District Treasurer for collection and the District Treasurer is authorized and directed to publish and mail notice as required by law stating that the roll is in his hands for collection and that payment of any assessment thereon or any portion of such assessment can be made at any time within thirty days from date of first publication of such notice without penalty, interest or cost, and that thereafter the principal sum remaining unpaid may be paid in 20 equal annual installments. The interest rate is stated to be and fixed at 3.50% per annum. The first installment of assessments on the assessment roll shall become due and payable during the thirty-day period succeeding the date one year after the date of first publication by the District Treasurer of notice that the assessment roll is in the hands of the Treasurer for collection and annually thereafter each succeeding

installment shall become due and payable in like manner. If the whole or any portion of the assessment remains unpaid after the first thirty-day period, interest upon the whole unpaid sum shall be charged at the rate as determined above, and each year thereafter one of the installments together with interest due on the unpaid balance, shall be collected. Any installment not paid prior to expiration of the thirty-day period during which such installment is due and payable shall thereupon become delinquent. Each delinquent installment shall be subject, at the time of delinquency, to a charge of 12% penalty levied on both principal and interest due upon that installment and all delinquent installments also shall be charged interest at the rate as determined above. The collection of such delinquent installments shall be enforced in the manner provided by law.

Assessments when collected shall be deposited into such fund of the District as the Commission may direct.

Section 4. The following conditions are found to be fair, equitable and lawful and are hereby adopted as requirements. Before a connection is made directly upon the improvements located within the boundary of Local Utility District No. 31, to serve a property not previously assessed, a charge in lieu of assessment shall be charged. The charge in lieu of assessment shall be \$19,188.90 for parcels that do not front the Skagit River, \$23,026.69 for parcels that front the Skagit River, and \$20,340.24 for all parcels over 50 acres, and at least the amount that comparable property located within the local utility district was assessed. Before such a connection to those improvements, property located inside such local utility district also shall pay accumulated construction inflation costs reflected in the Seattle Construction Price Index (CPI), and such source, supply, system, facilities use or other charges as the District may consider appropriate.
