5 Based on the accompanying Order Granting Plaintiff's Motion for Summary
6 Judgment, judgment is hereby entered in favor of Plaintiff ACE BEVERAGE
7 BELLINGHAM, INC. and against Defendant ELIZABETH JANINE PETERSON
8 establishing that:

10 1. The judgment entered by the Washington State Superior Court, in and for
11 Whatcom County in the case captioned *Ace Beverage Bellingham, Inc. v. Peterson*,
12 Case No. 08-2-01125-5 shall not be discharged in these bankruptcy proceedings,
13 pursuant to 11 U.S.C. § 523(a)(4) and (6);

14 2. Defendant Peterson is hereby obligated to pay Plaintiff Ace Beverage
15 Bellingham the principal amount of \$672,120.51, plus pre-judgment interest accruing at
16 12% per annum from July 30, 2010 through the date of entry of this judgment, with
17 judgment interest accruing thereafter at the federal rate of interest; and

19 3. Any amount paid by Defendant Peterson to Ace Beverage Bellingham in
20 satisfaction of the \$250,000 order of restitution entered in the Washington State
21 Superior Court in and for Whatcom County in the case captioned *State of Washington v.*
22 *Elizabeth Janine Peterson*, Case No. 08-1-00938-9 shall be credited against and
23 subtracted from the unpaid balance due on the judgment debt set forth in Paragraph 2,
24 above.
