## **EXHIBIT "A"**

## LEGAL DESCRIPTION

That portion of Government Lot 4 in Section 13, Township 34 North, Range 9 East, W.M., lying Westerly of the County Highway being more particularly described as follows:

Beginning at the intersection of the North line of said Government Lot 4 with the Westerly boundary of said County Highway, said point being on curve of said County Highway, the radius point of said curve bears North 57°25'41" East, a distance of 3859.73 feet,

thence Southeasterly along said curve to the left through a central angle of 2°52'15", an arc distance of 193.39 feet;
