SPECIAL LIMITED POWER OF ATTORNEY

I, GRACE ARNOLD, resident of Rancho Sante Fe, California, designate JULIA DE HAAN, resident of Seattle, King County, Washington, as my attorney-in-fact (referred to as the "Agent") on the following terms and conditions:

- 1. Authority to Act. The Agent is authorized to act for me under this Power of Attorney as described herein.
- 2. **Powers of Agent**. The Agent may act and exercise power, authority and control on my behalf, with regard to the following specific and limited purposes only:

- 3. **Durability**. The rights, powers and authority of my Agent as granted in this Power of Attorney shall commence and be in full force and effect on December 1, 2016. This Power of Attorney shall expire March 1, 2017, or at an earlier date if revoked by me in writing.
- 4. **Reliance by Third Parties**. Third parties may rely upon the representations of the Agent as to all matters regarding powers granted to the Agent. No person who acts in reliance on the representations of the Agent or the authority granted under this Power of Attorney shall incur any liability to me or to my estate for permitting the Agent to exercise any power prior to actual knowledge that the Power of Attorney has been revoked or terminated by operation of law or otherwise.
- 5. Indemnification of Agent. No agent named in this Power of Attorney or substituted in this Power of Attorney shall incur any liability to me for acting or refraining from acting under this Power of Attorney, except for such agent's own misconduct or negligence. I agree to indemnify and hold harmless any agent named or substituted in this Power of Attorney for any court costs, givil

judgments, or reasonable attorney fees that are incurred as a result of exercising the powers described herein. Original Counterparts.
