SUBORDINATION OF DEED OF TRUST

This Subordination of Deed of Trust is made as of the _______, 2017 by Skagit State Bank ("Subordinating Lender"), under the following circumstances:

A. Subordinating Lender is the holder of a Deed of Trust (the "Existing Deed of Trust") executed by **Jeffrey W. Huffstetler** ("Borrower"), in favor of Subordinating Lender in the original amount of \$60,000.00, recorded May 6, 2008 at Instrument #200805060061, the Public Records of Skagit County, Washington, which is a lien on the real estate described below (the "Property").

Lender, JP Morgan Chase Bank N.A., will be making a loan secured by a Deed of Trust, in the maximum principal amount of \$130,132.00 (One Hundred Thirty Thousand One Hundred Thirty Two Dollars and Zero Cents), to Jeffrey W. Huffstetler as Borrower, Pow Deed of Trust"), which will be a lien on the Property.

As part of the consideration for Lender's agreement to make the loan secured by the New Deed of Trust, and to induce Lender to make that loan, Subordinating Lender has agreed to subordinate the lien of the Existing Deed of Trust to the lien of the New Deed of Trust, upon the terms and conditions set forth in this Agreement.

NOW PHEREFORE, Subordinating Lender and Lender agree as follows:

- 1. Subordinating Lender hereby subordinates the lien of the Existing Deed of Trust to the lien of the New Deed of Trust; however, this subordination shall not otherwise affect the validity or priority of the Existing Deed of Trust.
- 2. This Subordination Agreement is made on the understanding that Subordinating Lender shall not be responsible for any of the obligations of Borrower contained in or secured by the New Deed of Trust.
- 3. This Subordination Agreement shall be binding upon and inure to the benefit of Lender and Subordinating Lender and their respective successors and assigns.
