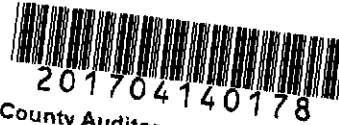

As of April 6, 2017, there is an outstanding balance of \$1,054.55 due and owing in connection with the following property at Skagit Highlands:



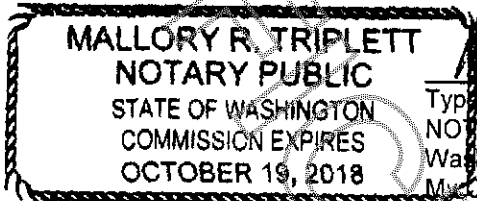
