

The Northwest $\frac{1}{4}$ of the Northeast $\frac{1}{4}$ of Section 8, Township 33 North, Range 4 East, W.M., EXCEPT the North 15 feet thereof conveyed to Skagit County for road purposes by deed recorded April 7, 1909, under Auditor's File No. 73064, in Volume 65 of Deeds, page 40, records of Skagit County, AND EXCEPT the as built and existing County road running along the West side thereof, AND EXCEPT ditch rights of way as set forth in Skagit County Superior Court Cause Nos. 5271 and 17539, AND EXCEPT the following described tract:
