WHEREAS, in the above-entitled court on January 27, 2017, Plaintiff, secured a judgment against defendant Merlin Joey Lane in the total judgment amount of \$205,137.52, together with interest at a rate of 6.62500% per annum, \$23.18 per diem from the date of judgment and continuing thereafter until the date of sale.
