1. This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between DAYLON L SWEENEY AND PATRICIA H SWEENEY, HUSBAND AND WIFE, as Grantor, to ADELITA A. 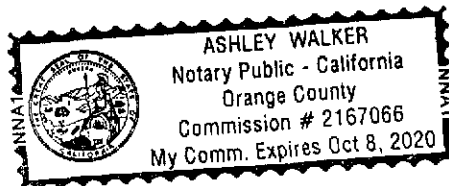
