The subject 15 Foot Easement location is relocated to run along the centerline of Lot 9, as measured along the North line of said Lot 9, 'PLAT-OF SKAGIT SUNSET DIVISION No. 1' as per Plat recorded in Volume 16 of Plats, Page 49 and 50, records of Skagit County, Washington, situate within the County of Skagit, State of Washington. The relocated easement will remain 15 feet in width, being 7.5 Feet on each side of the described centerline of said-Lot 9.
