I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that a WRIT OF EXECUTION did issue out of the Superior Court of SKAGIT County, Washington, on April 11, 2016, upon a judgment rendered in Superior Court of SKAGIT County, Washington on November 24, 2015, in favor of NATIONSTAR MORTGAGE LLC DBA CHAMPION MORTGAGE COMPANY, A LIMITED LIABILITY COMPANY, for the sum of two hundred seventy-one thousand, one hundred seventy-eight dollars and seventy-four cents (\$271,178.74).

The WRIT OF EXECUTION, issued to the Sheriff of Skagit County, Washington, was received by the Sheriff on April 25, 2016, and commanded the Sheriff to cause the amount of the judgment to be made out of the real estate described in the WRIT OF EXECUTION.
