This MEMORANDUM OF LEASE (this "Memorandum") is made as of July 21, 2017, by and between Gary Lee Westad and Sandra E. Westad, husband and wife ("Landlord"), and Kreider Construction, Inc., a Washington corporation ("Tenant"), as a memorandum of an unrecorded Lease (the "Lease") dated July 24, 2017, between Landlord and Tenant concerning the real property which is legally described herein above, together with the shop building located thereon (collectively, the "Premises").

1. Lease.  - B. The Tenant's interest in the Premises thereunder; and
 - C. The Option to Furchase and Lease are not, in any way, modified by this Memorandum.
