All that portion of the hereinafter described PARCEL "A" lying easterly of a line beginning at Highway Engineer's Station (hereinafter referred to as HES) 346 +25 on the SR 20 line survey of SR 20. S. Campbell Lake Rd. to Gibralter Rd. Vic.; thence northwesterly to a point opposite said HES 346+25 on said line survey and 75 feet northwesterly therefrom; thence northerly to a point opposite HES B 1+60 on the B-Line survey of said Highway and 40 feet southwesterly therefrom; thence northeasterly to said HES B 1+60 and the end of this line description.
