**GRANTOR.** The Grantor is Engbert "Andy" Van Esch, whose mailing address is 1108 S. 21st Street, Mount Vernon, Washington, 98273.

**LEGAL DESCRIPTION.** The real property that is the subject of this Revocable Transfer on Death Deed is situated in the County of Skagit, State of Washington, and is legally described as follows:

Lot 10, Block 1, 'Albert Balch's Wedgwood, an addition to Mount Vernon, WN.," as per plat recorded in Volume 7 of Plats, page 24, records of Skagit County, Washington, described as follows:

Commencing at the Northeast corner of said lot 10; thence South 0 degrees 57'37" West 76.12 feet along the East line of said lot 10 (shown as South 0 degrees 47"00" East on said plat) to the true point of beginning; thence South 51 degrees 28'21" West 40.24 feet to the Easterly margin of 20th Avenue in said plat (also known as 21st Street); thence Southerly along said Easterly margin being a curve concave to the Southwest having a radius of 100.00 feet and an initial tangent bearing of South 45 degrees 27'05" East, through a central angle of 46 degrees 24'42", an arc distance of 81.00 feet to the Southerly corner of said lot 10; thence North 0 degrees 57'37" East 98.02 feet along said East line of lot 10 (shown as North 0 degrees 47'00" West on said plat) to the true point of beginning.

The transfer that will occur under this Transfer on Death Deed at the time of the Grantor's death is exempt from the Washington Real Estate Excise Tax by reason of RCW 82.45.010(3)(b) and WAC 458-61A-202(7).
