II. STIPULATION

6 The Plaintiffs, Peter Hurd and Michelle Eighme, husband and wife, and the Defendants,
7 Ryan Wesley Walker, a single man, Daniel P. Walker and Lisa S. Walker, husband and wife,
8 (collectively "Defendants Walker") and U.S. Bank, NA, a/k/a U.S. Bank National Association
9 ("U.S. Bank"), through their attorneys of record, hereby stipulate as follows:

- 10 1. The Plaintiffs Peter Hurd and Michelle Eighme, husband and wife, are the owners
11 of that real property legally described on the attached **Exhibit A**.
- 12 2. The Defendants Walker are the owners of that real property legally described on
13 the attached **Exhibit B**.
- 14 3. U.S. Bank, has a security interest in the real property of Defendants Walker
15 described on the attached **Exhibit B**, represented by that Deed of Trust dated
16 October 21, 2015, recorded October 27, 2015 in Skagit County Auditor's File No.
17 201510270036.
- 18 4. Plaintiffs Hurd and Eighme claim a 30-foot strip of real property by adverse
19 possession, being a portion of the property of Defendants Walker legally
20 described on the attached **Exhibit B**. Said 30-foot strip of real property is legally
21 described on the attached **Exhibit C** and, for purposes of illustration only, is
22 generally depicted on the attached **Exhibit D**.
- 23 5. A dispute has arisen concerning the respective rights of the parties in a well
24 described in that Easement and Well Maintenance Agreement recorded on
25 September 14, 2000, in Skagit County Auditor's File No. 200009140062

1 6. The parties desire to settle their disputes by agreement as reflected in this
2 Stipulation and Judgment, and stipulate to entry of the following judgment as a
3 full and final settlement of the claims and defenses in this cause.

20 **III. JUDGMENT**

21 THIS MATTER coming on before the undersigned Judge of the above-entitled Court on
22 the foregoing stipulation; Plaintiffs, Peter Hurd and Michelle Eighme, husband and wife,
23 appearing through their attorney Patrick M. Hayden, and the Defendants, Walker appearing
24 through their attorneys Souders Law Group, and U.S. Bank appearing through its attorneys
25

1 Dorsey and Whitney, LLP; the Court having reviewed the files and records herein, and being
2 fully advised in the premises, now, therefore,

3 IT IS HEREBY ORDERED, ADJUDGED AND DECREED AS FOLLOWS:

4 1. **Adverse Possession Claim.** The Plaintiffs are hereby awarded all right, title and
5 interest of Defendants Walker in that 30-foot-wide strip of real property adjacent to his own real
6 property, described as follows:

7 The following real property of Defendants, or in which Defendants have an interest,
8 legally described as follows:

9 That real property legally described on the attached Exhibit C, and, for purposes of
10 illustration only, is generally depicted on the attached Exhibit D.

11 Situated in the County of Skagit, State of Washington.

12 Said real property is quieted in Plaintiffs free and clear of the interest of Defendants
13 Walker and of Defendant U.S. Bank through that Deed of Trust recorded October 27, 2015, in
14 Skagit County Auditor's File No. 201510270036.

15 Defendant U.S. Bank shall provide Defendants Walker and Plaintiffs with a partial
16 reconveyance for the property described above, and Plaintiffs shall pay the recording fee for the
17 recording of said partial reconveyance. Such partial reconveyance shall constitute the lender's
18 written consent to the transfer of the 30-foot wide strip described above, in accordance with the
19 Uniform Covenant 18 of the Deed of Trust described above.

20 **Boundary Line Adjustment:** The above-described 30-foot wide strip of real
21 property, which is legally described on Exhibit C, shall be combined with the adjacent real
22 property of Plaintiffs Hurd and Eighme, and shall not constitute a separate parcel or
23 building lot without compliance with the applicable county or municipal subdivision
24 ordinance. Plaintiffs shall be responsible for any county or municipal process and fees for this
25 boundary line adjustment, if any.

1 2. **Well/Water Dispute.** The shared Easement and Well Maintenance Agreement
2 recorded on September 14, 2000, in Skagit County Auditor's File No. 200009140062, is hereby
3 modified as follows:

4 (A) The Plaintiffs and the Defendants Walker shall each have a right to use 50% of
5 the water from the well.

6 (B) The use of the well and water shall not be extended to serve any other real
7 property or residences except the property described in the agreement and as
8 herein modified, but shall be limited to serving two residences and associated
9 gardens, lawns, etc., unless both owners agree otherwise in writing.

10 (C) Plaintiff Hurd and Defendants Walker, and their successors in interest, shall each
11 pay 50% of the cost of future maintenance, repair, and operation of the well and
12 common appliances, provided, that each owner shall maintain their own service
13 line to their own residence at the residence owner's expense.

14 (D) If there is a shortage of water, at the request of either party, the owners shall
15 install meters, and neither owner shall use more than 50% of the available water
16 as shown by metering.

17 (E) The Plaintiffs shall connect to the PUD #1 water main, disconnect from the well,
18 and abandon the well easement when PUD water service is available, which shall
19 be defined as a connection-ready PUD line at the intersection of Plaintiffs'
20 driveway and Garden of Eden Road or a point closer to Plaintiffs' house for
21 which a connection is practical, without any obligation on the part of Plaintiffs or
22 Defendants Walker to pay for construction costs of the PUD main. Plaintiff shall
23 pay for their own meter installation and standard connection fees and Defendants
24 shall have no obligation to pay for these costs.


1 (F) Except as modified herein, said agreement shall continue in full force and effect.
2 These modifications shall be binding on the Plaintiffs and Defendants as their
3 interests appear, and their successors in interest.

4 **3. Lis Pendens.** This judgment is binding from and after February 26, 2016, the
5 date of recording the Lis Pendens in Skagit County Auditor's File No. 201602260101, as to
6 Plaintiffs, Defendants, and all persons claiming or to claim by or through Plaintiffs and/or
7 Defendants, pursuant to RCW Ch. 4.28.160. Plaintiffs and Defendants are forever barred from
8 asserting any title, estate, lien or interest in the real property and well described herein, contrary
9 to this judgment, which shall run with the land and shall bind the parties, their heirs, devisees,
10 and successors in interest. This matter having fully adjudicated the claims for which the Lis
11 Pendens gives notice, the Lis Pendens shall have no other affect after the date this judgment is
12 recorded with the Auditor. Within 7 days of the entry of this Stipulation and Judgment by the
13 Court, Plaintiffs shall record a complete release of said Lis Pendens.

14 **4. Remaining Claims.** The remaining claims of the parties are hereby dismissed
15 with prejudice.

16 **5. Costs and Attorney Fees.** Each party shall bear their own costs and attorney fees
17 in this case.






Exhibit Map
