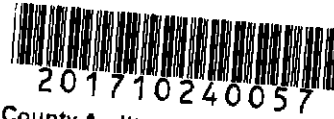

SUSAN J. CARLISLE, being first duly sworn, on oath, deposes and says:

1. This Affidavit provides information for the record regarding that certain Agreement as to Status of Community Property dated October 16, 2001, executed by **WILLIAM G. CARLISLE** and **SUSAN J. CARLISLE**, husband and wife (the "Agreement"). The Agreement was recorded in the Office of the County Auditor in Skagit County, Washington, on October 17, 2017, under File No. 201710170055. The statements set forth in this Affidavit are representations of fact that may be relied upon by all parties dealing with the real estate located in Skagit County, Washington, and more fully described in paragraph 4 on page 2.

2. **WILLIAM G. CARLISLE** (the "Decedent"), a resident of the State of Washington, was one of the parties to the Agreement and died on September 19, 2017, in Anacortes, Skagit County, Washington.

3. The parties to the Agreement were legally competent at the time of the Agreement

and executed no subsequent Wills or agreements that would have the effect of abrogating or nullifying the Agreement. The Agreement was validly executed and in full force and effect at the time of the Decedent's death.

4. The legal description for community real property of the Decedent and the affiant is set forth below:

Unit B-102, "THE CREST AT SUNSET COVE CONDOMINIUMS," a condominium, according to the Survey Map and Plans thereof recorded May 4, 2006, under Auditor's File No. 200605040034 and as identified in that certain Declaration thereof recorded May 4, 2006, under Auditor's File No. 200605040035, and amended May 25, 2006, under Auditor's File No. 200605260013, and further amended December 20, 2006, under Auditor's File No. 200612200021, and August 4, 2009, under Auditor's File No. 200908040051, and December 10, 2009, under Auditor's File No. 200912100045, records of Skagit County, Washington. Situate in the City of Anacortes, County of Skagit, State of Washington.

5. The Decedent left no separate property.

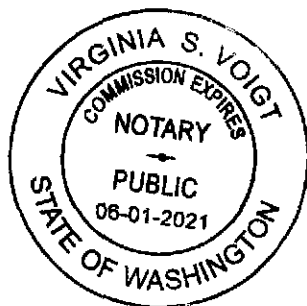
