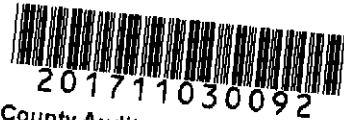

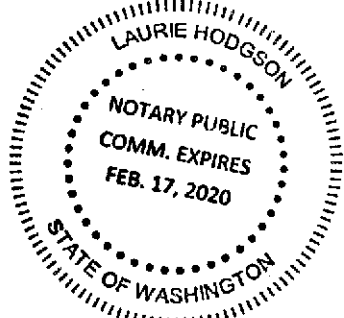

**DESCRIPTION:**

All that portion of Lots 2 and 3, Short Plat No. 67-80, approved April 21, 1981, recorded April 22, 1981, in Volume 5 of Short Plats, page 60, under Auditor's File No. 8104220037, being a portion of the Southeast  $\frac{1}{4}$  of the Northwest  $\frac{1}{4}$  of Section 14, Township 34 North, Range 1 East, W.M., described as follows:
