- 1. **GRANTOR.** The undersigned, Jill Saxton, is the duly appointed, qualified and acting personal representative of the Estate of Margie E. Conard, deceased.
- 2. **ESTATE.** Margie E. Conard died on June 23, 2016. On August 22, 2016 Grantor was appointed personal representative of decedent's estate and granted non-intervention powers for the administration of decedent's estate in the State of Washington Superior Court of Yakima County in Cause No. 16-4-00493-39 (the "Probate Proceedings").
- 3. **NONINTERVENTION POWERS.** By Order entered on August 22, 2016 in the Probate Proceedings, Grantor was authorized to settle the Estate without further court intervention or supervision.
