- (A) "Security instrument" means this document, which is dated November 17, 2017, together with all Riders to this document.
- (B) "Borrower" is WILLIAM L. JOHNSON and RITA J. JOHNSON, husband and wife. Borrower is the trustor under this Security Instrument.
- (C) "Lender" is NorthWest Plus Credit Union. Lender is a State Chartered Credit Union organized and existing under the laws of THE STATE OF WASHINGTON. Lender's address is 2821 Hewitt Ave. Everett, WA 98201. Lender is the beneficiary under this Security Instrument.
- (D) "Trustee" is Land Title and Escrow-Skagit County, 111 E George Hopper Rd, Burlington, WA 98233.
- (E) "Note" means the promissory note signed by Borrower and dated November 17, 2017. The Note states that Borrower dwes Lender FOUR HUNDRED THOUSAND AND NO/100 Dollars (U.S. \$400,000.00) plus interest. Funds for Escrow Items. 4. Charges; Liens. Borrower shall pay all taxes, assessments, charges, fines, and impositions attributable to the Property which can attain priority over this Security Instrument, leasehold payments or ground rents on the Property, if any, and Community Association Dues, Fees, and Assessments, if any. To the extent that these items are Escrow Items, Borrower shall pay them in the manner provided in Section 3.

This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. 9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. acceleration and opportunity to cure given to Borrower pursuant to Section 22 and the notice of acceleration given to Borrower pursuant to Section 18 shall be deemed to satisfy the notice and opportunity to take corrective action provisions of this Section 20.

21. Hazardous Substances.
