. 1 55 Based on the foregoing, this Court finds there is no just reason for delay and there are no genuine issues of material fact in dispute as to Plaintiff's relief requested, and Plaintiff is entitled to judgment as a matter of law, now therefore, IT IS HEREBY

ORDERED, ADJUDGED AND DECREED as follows:

1. Plaintiff's Motion for Partial Summary Judgment is GRANTED on the following issues: (1) Defendant Gallagher's liability for breach of the December 19, 2014, "24-Hour Emergency Service Work Authorization"; (2) Defendant Gallagher's liability for breach of the December 19, 2014, "Service Work Authorization"; (3) the amount of the minimum damages owed by Defendant Gallagher for Phase I work performed by All New Again under the January 9, 2015, "24-Hour Emergency Service Work Authorization" in the amount of \$40,000.00, and (4) the amount of liquidated damages owed by Defendant Gallagher for breaching the December 19, 2014, "Service Work Authorization" in the amount of \$29,199.67 plus Washington State sales tax in the amount of \$2,365.17 for a total of \$31,564.84.

2. All New Again is granted judgment against Defendant Gallagher in the amount 70000. For Phase I work performed by All New Again on Defendant Gallagher's fesidence;

3. All New Again is granted judgment against Defendant Gallagher in the amount of \$29,199.67 plus Washington State sales tax of \$2,365.17 for a total of \$31,564.84 for liquidated damages for Defendant Gallagher's breach of the December 19, 2014, "Service Work Authorization";

4. Plaintiff All New Again as prevailing party, is entitled to an award of costs and reasonable attorney fees and shall file its motion for fees within thirty (30) days;
