I, Will Reichardt, Sheriff of Skagit County, State of Washington, do hereby certify that an ORDER OF SALE did issue out of the Superior Court of SKAGIT County, Washington, on April 5, 2017, upon a judgment rendered in Superior Court of SKAGIT County, Washington on December 23, 2016, in favor of NATIONSTAR MORTGAGE LLC D/B/A CHAMPION MORTGAGE COMPANY, for the sum of eighty-two thousand, three hundred eighty-one dollars and sixty-eight cents (\$82,381.68).
