other necessary or convenient appurtenants

3. Restrictions imposed by instrument recorded November 7, 1945, under Auditor's File No. 386666, records of Skagit County Washington, as follows:

The tracts herein sold shall be used for dwelling property only and no part thereof shall be used for any dance hall, store, amusement resort or for any commercial purposes of any kind or nature whatsoever; the restrictive covenants are agreed as covered running with the title to the said tracts herein sold and violations of any of them shall cause the title of said tracts to revert to grantors and heirs, executors and assigns and said grantors and heirs, executors and assigns, may maintain suit for injunction and damages to enforce the restrictions or violations thereof.
