THIS TERMINATION OF LEASE AND TERMINATION OF MEMORANDUM OF LEASE ("Termination") is effective as of the 17th day of January, 2018 (the "Effective Date") by and between WELLTOWER INC., fka HEALTH CARE REIT, INC., HCRI NEVADA PROPERTIES, INC. and 1111 W.
