RELEASE OF EASEMENT

THIS RELEASE OF EASEMENT (the Release) is given as of this <u>22</u> day of March, 2018, by Bruce F. Biddle (Grantee), whose address is 1004 Commercial Avenue, FMB 1043, Anacortes, Washington 98221.

WHEREAS, Grantee is the owner of certain real property commonly known as 2720 West 2nd Street, Anacortes, Washington 98221 (formerly 2719 Oakes Avenue, Anacortes, Washington 98221), and more fully described as follows: Lots 9 & 10 Block 203 NP to Anacortes, recorded in Vol. 2 of Plats, pg. 9, Records of Skagit County, Washington (the Dominant Estate):

WHEREAS, an easement on and across certain real property described as Lots 9 & 10 Block 202 NP to Anacortes, recorded in Vol. 2 of Plats, pg. 9, Records of Skagit County Washington (the Servient Estate) was granted to Grantee for ingress and egress purposes by Real Estate Easement Agreement dated August 23, 2016, and recorded on August 30, 2016, in the Records of Skagit County (Doc. No. 201608300087) (the Biddle Easement);

WHEREAS, Section 9 of the Real Estate Easement Agreement authorizes Grantee to release the Biddle Easement at any time by executing and recording a release; and

WHEREAS, the purpose of the easement has ceased to exist and Grantee would like to release the easement;

NOW THEREFORE, for nominal consideration, Grantee agrees as follows:

- Release of Easement. Grantee hereby terminates, releases and relinquishes all easements
 and other rights created or reserved in the favor of the Dominant Estate by virtue of the
 Biddle Easement.
- 2. Binding Effect. The covenants contained in this Release are not personal but shall run with the land and shall be binding upon and inure to the benefit of the fee simple title holder of

the Dominant Estate, and their respective heirs, personal representatives, transferees, successors or assigns.
